This purchase gives a guaranteed title to the Cremated Remains Green Burial Privilege to the above named Client, and is not subject to refund as per MCA 37-19-827, nor to any price modification at time of delivery or need, but is subject to the following conditions and limitations as listed below:

1. The Cremated Remains Green Burial Space will be used only once, for the burial of cremated remains delivered to Infinity Cemetery LLC by Grantee.
2. The Green Burial Space will be maintained solely by Infinity Cemetery LLC, remaining in the natural pristine condition of typical wildland of this location – with only native vegetation.
3. After burial, all Green Burial Spaces are fully restored to their natural condition, and are soon essentially invisible. The remains are thus completely returned to nature.
4. No surface markers or memorials of any kind are allowed within Infinity Cemetery. Infinity Cemetery LLC will record the exact location of the Green Burial Space with latitude and longitude coordinates, to prevent reuse. Included with this Conveyance of a Cemetery Burial Privilege is access to one Virtual Online Memorial Page of up to 100 MB, in the name of the deceased, to be hosted forever by Infinity Cemetery LLC at [infinitycemetery.com](http://infinitycemetery.com).
5. The use of the Green Burial Space and Memorial Page shall be subject to the Rules and Regulations of Infinity Cemetery LLC, as they presently stand or are later amended and posted at [www.infinitycemetery.com](http://www.infinitycemetery.com) and the laws of the State of Montana, USA.
6. Infinity Cemetery LLC hereby covenants to deposit in an irrevocable and perpetual care and maintenance trust 15% of the gross sale price, to protect and maintain: the Green Burial Space in an undisturbed, wildlands condition; the Infinity Cemetery Sanctuary and Memorial Garden; and to host the associated Memorial Pages, for as long as the laws of the State of Montana governing this Conveyance are in force.
7. Related to this Conveyance of a Cremated Remains Green Burial Privilege , there are no additional costs or charges for burial services, including graveside services. The Virtual Online Memorial Page is an option and may be kept private by Grantee.
